Distracted Teens Behind the Wheel are Deadly Combination

Automobile accidents are the leading cause of deaths for teens in the United States, according to the Center for Disease Control and Prevention. Federal estimates suggest that distraction contributes to 16% of all fatal crashes, leading to around 5,000 deaths every year. The AAA Foundation for Traffic Safety Culture Index recently published a study which showed that teen drivers were distracted almost a quarter of the time they were behind the wheel. Electronic devices, such as texting, emails, and downloading music, were among the biggest distractions.



Fortunately, there are ways to prevent the severity of these accidents. Of the teens (aged 13-19) who died in passenger vehicle crashes approximately 55% were not wearing a seat belt at the time of the crash. Research shows that seat belts reduce serious crash-related injuries and deaths by about half. It is also important for the parents to provide at least 30 to 50 hours of supervised driving practice over at least six months. Practice on a variety of roads, at different times of day, and in varied weather and traffic conditions will help an inexperienced driver. Stress the importance of continually scanning for potential hazards including other vehicles, bicyclists, and pedestrians. Most importantly, don't allow activities that may take your teen's attention away from driving, such as talking on a cell phone, texting, eating, or playing with the radio.
